



Hexavalent Chromium (Cr(VI)) Testing Flow Chart



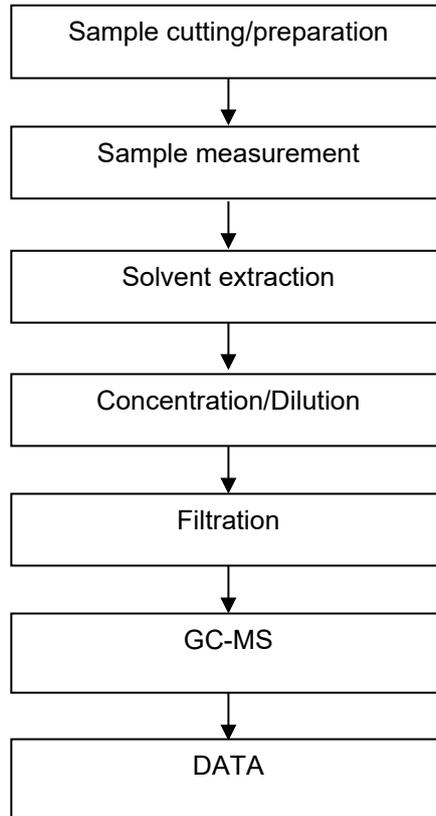

PBB(s)/PBDE(s)/Phthalates Testing Flow Chart



Halogen Testing Flow Chart





